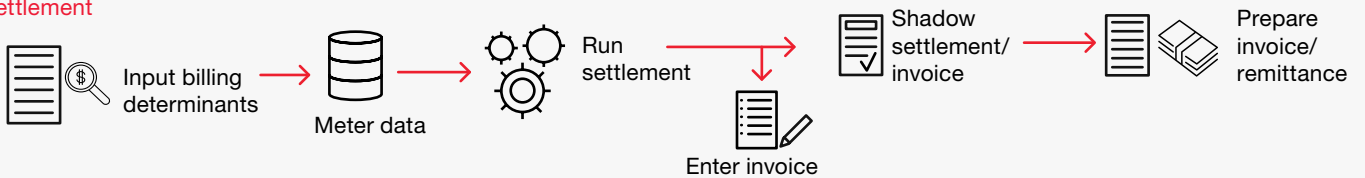
The system automates all processes from meter data and billing determinants management to settlement and shadow settlement with counterparties.

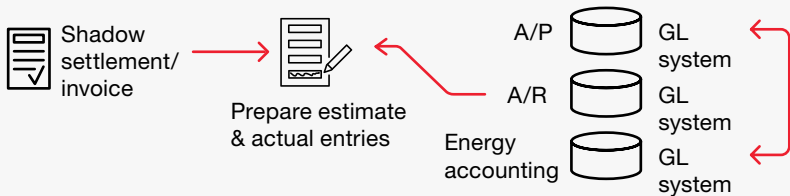
