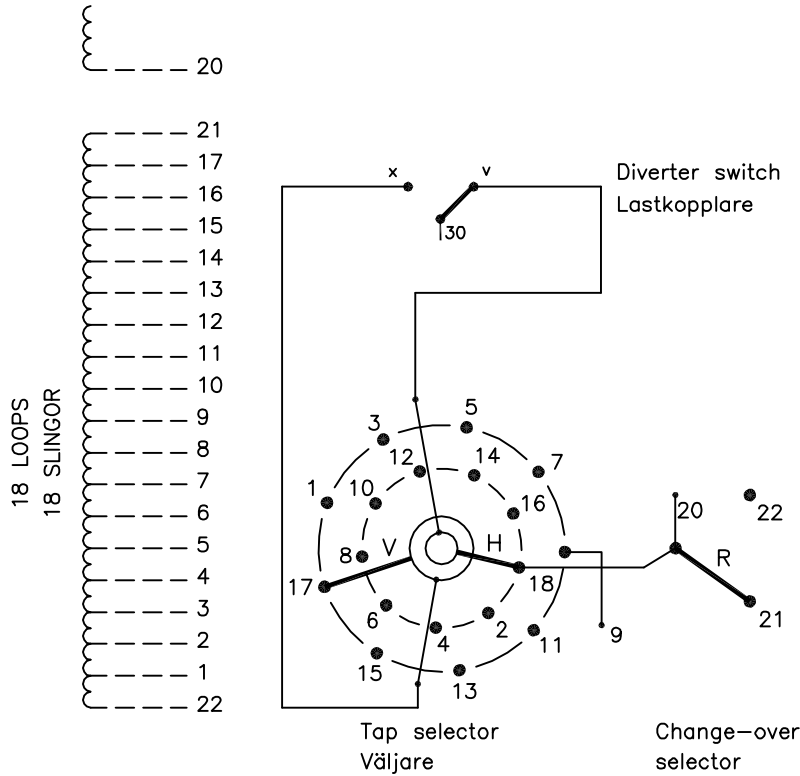


On-load tap-changer type VUCGR./C and UCGR./C, 35 tap positions, plus/minus switching.
