Rules & regulations

Duration

From January 1st to December 31st, 2025

Eligibility

Participants must be legal residents of Canada and 18 years of age or older and must follow the entering process with a valid entry.

Excluded are ABB employees, ABB distributor employees and ABB supplier employees.

ABB has the right to require proof of identity or eligibility from the participant in order for him/her to participate in the contest. Failure to provide such proof can result in disqualification.

How to enter

To participate, a person must enter the promotion online via the promotion platform. Participants are required to:

The picture(s) must clearly show the WP wire connector(s) (**WP33M9, WP33B25, WP33JAR150, WP39M6, WP39B20, WP39JAR100**), its(their) installation and its(their) surroundings installation area, ensuring the purpose of the installation is easily understood. The installation must comply with the Canadian Electrical code currently in effect at the time of participation.

Eligibility will be validated by means of the promotion answers, picture(s), as well as employee, suppliers and distributors' lists.

Only one admissible participation per participant is permitted.

The first 150 eligible participants who completed the promotion registration form between **January 1st** at 9:00 AM and **December 31st** 16:00 PM, 2025 (eastern time) will receive their t-shirt according to the information they provided.
