

Special Terms and Conditions to ABB Ability Marketplace® General Terms and Conditions (“Marketplace GTC”) and ABB Ability™ General Terms and Conditions (“Ability GTC”)

for

Field Information Manager Universal Motor Controller (“FIM UMC”) Edition Software

1. Definitions and interpretations

All capitalized terms used in these Special Terms and Conditions (“STC”) shall have the meaning described in the Ability GTC or Marketplace GTC, except where the context of these STC require otherwise.

1.1. Definitions

“ABB Ability™” is a trademark of ABB Asea Brown Boveri Ltd which is associated with ABB and its Affiliates unified, cross-industry, digital capability and solutions;

“ABB Software” means all computer programs (which may include mobile applications) provided (or given access to) by us under the Contract, including any modifications, updates, upgrades, new versions or releases and derivative works as well as any related documentation, but excluding Third Party Software;

“FIM” means ABB Ability™ Field Information Manager. FIM UMC Edition Software is a part of FIM for the configuration of the UMC100.3;

“FIM UMC Edition Software” means the full version of the ABB Software called FIM UMC Edition for the configuration of the UMC100.3;

“Free Version of FIM UMC Edition Software” means the free trial version of the FIM UMC Edition for the configuration of the UMC100.3.

“UMC100.3” means the ABB Universal Motor Controller;

“UMC100.3 Device Package” means the Device Package that describes the parameter structure of the UMC100.3, which enables the Free Version of FIM UMC Edition Software and FIM UMC Edition Software to communicate with the UMC100.3.

2. Scope

2.1. These STC relate to the FIM UMC Edition Software.

3. Product description

3.1. The FIM UMC Edition Software is enabled through the Free Version of FIM UMC Edition Software. The download and installation of Free Version of FIM UMC Edition Software is a prerequisite for the enablement of the FIM UMC Edition Software.

3.2. The Free Version of the FIM UMC Edition Software:

- i. Can be downloaded from (a) the email sent by ABB Ability Marketplace®, (b) the ABB website (to.abb/wKCp5UrG), or (c) if purchased by the Customer, the USB stick;

- ii. Shall be installed and used in an online mode, meaning a UMC100.3 needs to be physically connected to the computer;
- iii. Allows the user to connect and configure online with Profibus DP and on a serial link with a USB cable connected to the control panel. It also allows to parametrize the UMC100.3, monitoring its status data and its operation online.

3.3. When Customer purchases the FIM UMC Edition Software, it will receive a file (*.sla) to upgrade the Free Version of FIM UMC Edition Software to FIM UMC Edition Software version. Customer can either drag and drop the file directly in the Free Version FIM UMC Edition Software or import it.

3.4. FIM UMC Edition Software contains the additional features of project management and offline UMC100.3 configuration and printing, which are not part of the Free Version of FIM UMC Edition Software. The technical data sheet and related documents of this product can be found at to.abb/wKCp5UrG.

3.5. The requirements for FIM UMC Edition Software installation are: Windows 10 and Windows admin rights.

3.6. When experiencing difficulties with USB drivers in Windows, Customer can find further instructions at to.abb/sf2Dvy52.

3.7. These STC does not include hardware products including, but not limited to cable and Profibus DP interface.

4. Licensing terms and Restrictions

4.1. Subject to the terms of the Contract, ABB hereby grant Customer a non-exclusive, non-transferable, perpetual and limited single license to use the FIM UMC Edition Software for Customer internal business purposes and/or to provide services to its end user customers.

4.2. Customer is allowed to use this single license of the FIM UMC Edition Software only in one computer unit, where the ABB Software was installed.

4.3. This single license can only be applied to one installation of the Free Version of FIM UMC Edition Software. In case of complete deletion of the of Free Version of FIM UMC Edition Software in the computer unit, the license can be reapplied on a new installation of Free Version of FIM UMC Edition Software in another computer unit.

5.Update versions

5.1. ABB may make available from time to time update versions of ABB Software. Updates or upgrades shall be governed by the terms and conditions of the Contract unless such updates or upgrades are accompanied by a separate license provided by ABB in which case the terms and conditions of such separate license will take precedence over other documents forming the Contract with regards to any conflicting terms. Notwithstanding the foregoing, ABB is not obliged to provide any updates or upgrades to the ABB Software.

5.2. In case an update is available, it can be downloaded from the ABB website after registration using this link: to.abb/EKWbWNR6

5.3. Before installing an update, Customer must export and save separately any Customer Content including, but not limited to, former projects; or otherwise it might be lost.

5.4. If update versions of the UMC100.3 Device Package are available, they can be downloaded within the FIM UMC Edition Software and for the Free Version of FIM UMC Edition Software in the device catalog. Online connection is required or Customer can download the file at to.abb/KkXNBEuF (under the tab Documents >> Software).

6. Special delivery terms for online purchase

6.1. When purchasing FIM UMC Edition Software in ABB Ability Marketplace®, the order will be handled in two steps:

6.1.1. Direct after ordering

When the order is placed, Customer will receive an email from the ABB Ability™ Marketplace. All files contained in this email, except the file (*.sla), can be downloaded as a zip-file from the provided link in the email.

6.1.2. After payment received

When the payment is received by ABB, Customer will receive a second email from the ABB Ability Marketplace® which includes the link to download the file (*.sla). Once the file (*.sla) is dragged and dropped directly in Free Version FIM UMC Edition Software or imported by the Customer, the Free Version of FIM UMC Edition Software will be upgraded to the FIM UMC Edition Software.
