TSCA Declaration

Five rules were issued on 6 January 2021 by the US Environmental Protection Agency (EPA) under the US Toxic Substances Control Act (TSCA) Section 6(h) to reduce exposure to certain chemicals that are persistent, bioaccumulative and toxic (PBT). The rules limit or prohibit the manufacture (including import into the US), processing, and/or distribution in commerce for the following PBT substances:
