- Torx screwdrivers, T10, (T8), T15, T20

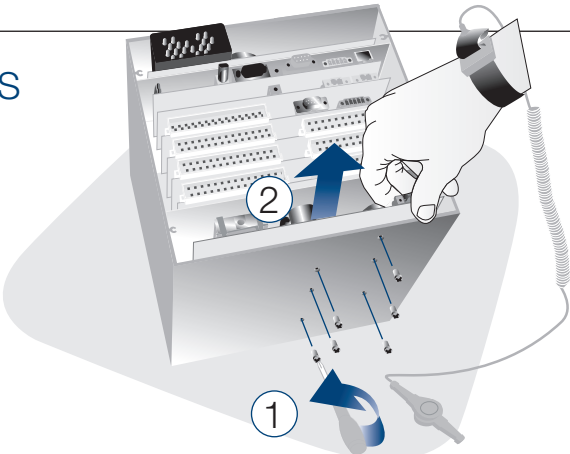
- 1 ESD wrist wrap
