Condition of Service

- Chargeable time includes time spent at the client's facility, round trip travel, time spent off-site preparing written reports, and the time for all the other activities required on the client's behalf.
- A minimum of eight (8) hours is charged for any service call to a client's facility.

Stand by Time

- If a person is requested by the customer to standby on or in the vicinity of the customer site, standby hours will be billed using applicable rates above. If a person is not requested, no charges will be applied, however; the person will not be available to work, is considered unassigned, and is free to be assigned to other projects.

Cancellation Fee

- per ABB Standard T&Cs any order may be cancelled by Purchaser only upon prior written notice and payment of termination charges, including but not limited to, all costs identified to the order incurred prior to the effective date of notice of termination and all expenses incurred by ABB attributable to the termination, plus a fixed sum of ten (10) percent of the final total price to compensate for disruption in scheduling, planned production and other indirect costs.
- Expediting Fee: ABB will charge a \$500 expediting fee for all services with requested start date within 5 business days from request for service.

Overtime Hours

- For billing purposes ABB Inc. defines overtime as those hours worked outside the Primary Working Hours or in excess of eight (8) hours in one day. The standard charges for overtime are defined as follows:
- All work performed outside the Primary Work Hours or over 8 hours in one day is charged at one and one-half times the labor rate (Base Service Labor Rate X 1.5).
- All work performed on Saturday is charged at one and one-half times the labor rate (Base Service Labor Rate X 1.5).
- All work performed on Sunday, National/ABB recognized Holidays is charged at two times the labor rate (Base Service Labor Rate X 2).

Travel Expenses

- Travel Time: To be charged at applicable travel rates as listed above.
- Transportation and Living: Cost +10% (Airfare, hotel, rental car, train, boat, taxi, etc.)
- Mileage: IRS Standard Mileage Rates (<https://www.irs.gov/tax-professionals/standard-mileage-rates>)
- Food & Incidentals Per Diem: \$75.00 (Domestic)

- Shift greater than 12 hours per day must be agreed upon prior to project start (no shift to exceed 14 hrs. per day)
